4. Contractual basis

The contractual basis for participation in MedtecLIVE innovation expo at MedtecSUMMIT are the Special Terms and Conditions of Participation of MedtecLIVE innovation expo at MedtecSUMMIT as well as the General Terms and Conditions of Participation, the organizational (e.g. exhibitor information), technical (e.g. online exhibitor store) and other provisions (in particular the house rules and the other safety regulations of the venue) that are sent to the exhibitor before the start of the event. Furthermore, the terms of use for the MedtecLIVE digital platform apply, as every exhibitor also receives an entry on this digital platform. If the license and terms of use of the MedtecLIVE digital platform and the Special Terms of Participation of MedtecLIVE innovation expo at MedtecSUMMIT contradict each other, the latter shall take precedence.

5. Admission / Stand space confirmation

In addition to item 2 of the General Conditions of Participation for Trade Fairs and Exhibitions, the following applies: If the exhibitor cancels the stand space order before stand space confirmation, he undertakes to pay a processing fee of EUR 250.

Point 7 of the General Terms of Participation for Trade Fairs and Exhibitions applies to cancellations after stand space confirmation.

6. Exhibitors and admitted exhibits

The following are admitted as exhibitors Manufacturers, importers, wholesalers, commercial agents and publishers from Germany and abroad with products and services that can be categorized in the specified product groups. All exhibits must be specified in the application. Goods that violate the provisions of industrial property rights in Germany (plagiarism) are not permitted.

7. Package price in exhibition halls

The stand area is 9 m², row and corner stands can be booked.

Row stand 4,500.00 EUR

Corner stand 4,700.00 EUR

The following services are included in the package price: Stand construction and equipment

- Carpeting
- High-quality stand construction
- 1 lockable counter
- 1 brochure stand
- 1 high table, 2 bar stools

- Power connection (230 V/3 KW incl. consumption and socket)

- AUMA fee
- Waste disposal service, daily cleaning
- Catering on site
- 2 tickets for the MedtecSUMMIT

- 1 VIP parking pass
- Provision of advertising material to promote participation (e.g. banners)
- Entry in the MedtecSUMMIT Pocket Guide with at least name and stand number as well as logo on the MedtecSUMMIT website
- Rental of the stand space during set-up, running time and dismantling
- General surveillance of the exhibition halls. General lighting of the exhibition halls. General cleaning of the aisles.

8. Terms of payment

With the confirmation of registration, the exhibitor may be charged an advance payment of 50% of the expected stand space rental. With the stand space confirmation, the exhibitor will be charged the full stand space rental fee, taking into account the advance payment. The advance payment will be refunded if no admission and no stand space confirmation is issued. Invoices are due on the date stated on the respective invoice and are payable without deduction. All payments are to be made free of charge and in EURO, quoting the invoice number. If the exhibitor indicates a different invoice address on the registration form, he authorizes the person/company indicated to receive the invoice and other requests for payment. This does not release the exhibitor from his obligation to pay.

The organizer or NürnbergMesse GmbH may charge a processing fee of EUR 50 for subsequent changes to the invoice for which the exhibitor is responsible. The same applies to cases in which additional expense is incurred as a result of NürnbergMesse entering invoices and/or associated information, data and documents into the exhibitor's invoice processing systems or portals. A claim to the allocated stand space only exists after full payment of the invoices. Proof of payment must be provided by the exhibitor.

The exhibitor agrees to the sending of invoices by the organizer and, if applicable, the organizer, NürnbergMesse and its service partners by e-mail (electronic invoicing).

If the exhibitor does not wish invoices to be sent electronically, he may object to this in writing or in text form.

9. Insurance

Exhibitors are generally obliged to take out adequate insurance cover themselves. It is recommended that exhibitors take out exhibition insurance to cover the risk of transportation and sojourn.

10. Assembly and dismantling

Assembly on Monday, February 17, 2025 from 5:00 p.m. to 8:00 p.m. and on Tuesday, February 18, 2025 from 7:00 a.m. to 8:30 a.m.

Exhibition stands that have not been set up by 8:00 a.m. on Tuesday, 18 February 2025 will be set up by the organizer, unless otherwise agreed. Any costs arising from this shall be borne by the exhibitor.

The exhibitor undertakes to comply with the specified times, in particular to completely vacate his stand area by Wednesday, February 19, 2025, 9:00 p.m.

If the exhibitor fails to comply with this obligation and this results in a collision with the set-up of the subsequent event, the exhibitor shall be obliged to bear all costs incurred as a result. This applies in particular to claims for damages against the organizer or MedtecLIVE GmbH.

11. Stand design, stand support

11.1 Stand design

The stand partition walls (hard fiber structure) may only be treated with water-soluble adhesives and may not be painted without prior wallpapering. Wallpaper or other wall coverings must be removed by the exhibitor after the event.

Otherwise the stand partition walls will be cleaned at the exhibitor's expense. All other stand partition walls, floors, hall walls, pillars, installation and fire protection equipment and other fixed hall fittings may not be pasted, nailed, painted or damaged in any other way. Any damage will be charged to the exhibitor. Any pillars located in the stand area as well as installation and fire protection equipment are part of the allocated stand space and must be accessible at all times.

Floor coverings in the exhibition stands may only be affixed with double-sided adhesive tape 11.1 Stand design (only with solvent-free adhesive tapes: tesafix no.

The exhibitor undertakes to comply with these requirements. In the event of violations may result in claims for damages by the organizer, NürnbergMesse GmbH or the affected neighboring exhibitors.

11.2 Stand support

No dismantling of exhibition stands and/or no handing over of products before the end of the fair (except for samples, specimens and promotional gifts). The event ends at 17:30 on the last day of the fair. Each exhibitor undertakes to

- to occupy their stand space with stand personnel
- not to hand out any products to interested parties (except samples, specimens and promotional gifts)
- not to begin dismantling the exhibition stand

Any infringement may be punished by the organizer or NürnbergMesse GmbH may impose a contractual penalty on the exhibitor. The penalty is 20% of the net stand rental, but at least EUR 500. The organizer also reserves the right to exclude the exhibitor from future participation in MedtecLIVE.

12. Data protection notice

Personal data will be processed by the organizer as the responsible body within the meaning of data protection law as well as NürnbergMesse and, if applicable, ServicePartners in compliance with the relevant data protection regulations for the support and information of customers and interested parties as well as for the processing of the services offered (legal basis: Art. 6 para. 1 lit. b EU GDPR).

In accordance with the principle of data minimization and data avoidance, only data that is absolutely necessary for the stated purposes is processed. Personal data is of course treated confidentially and protected in the best possible way by appropriate security measures.

Only authorized persons who are involved in technical, commercial and customer administration have access to your data. Where required by law, the corresponding order processing contracts have of course been concluded.

Personal data will be stored until the contractual relationship with the organizer has ended and the data is no longer required for other legal reasons (e.g. due to statutory retention periods).

Every exhibitor has the right to complain about this data processing to the competent supervisory authority for data protection and can request information, correction, deletion or restricted processing, object to the processing or assert their right to data portability under the legal requirements. 13. Exhibitor claims, written form, place of fulfillment, place of jurisdiction

All claims of the exhibitor against the organizer or NürnbergMesse must be asserted in text form (§ 126b BGB). The limitation period begins on the last day of the event.

Agreements that deviate from these terms and conditions or the provisions supplementing them must be made in text form (§ 126b BGB).

German law and the German text shall apply exclusively. The place of fulfillment and jurisdiction is Nuremberg. However, the organizer reserves the right to assert its claims at the court of the place where the exhibitor has its registered office.
